**ORDER**

Whereas a rockslide has occurred on the 20<sup>th</sup> April, 2026 at Mawlieh stretch (Ch 35+450 kms) of NH260 under the jurisdiction of this Sub-Division wherein two lives were lost due to the incident and also rendering the road unsafe for vehicular movement,

Whereas due to the present climatic conditions, and excavation of rocks and soil on the hillside poses imminent hazards of rockslide/landslide thereby posing danger to human lives and property.

Now, therefore, it is imperative to ensure public safety and prevent any further untoward incident, and in continuation of the public notice issued vide letter No.PSD/GEN/9/2019/170, Dated 20/04/2026, it is hereby ordered that the said stretch of NH260 from Laitlyngkot upto Mawlieh (Ch 22+00 to Ch 35+450 kms) shall continue to remain close for all kinds of traffic.

This restriction shall remain in force until a thorough inspection and ground safety assessment is conducted by the competent authorities and the said under-construction road is certified fit for public use or a report with corrective suggestions is submitted whatsoever.

All concern officials are hereby directed to:

- Erect barricades and place proper warning signages at both ends of the affected stretch.
- Deploy personnel to regulate traffic and prevent entry.
- Disseminate informations to the general public through appropriate means.

The Police Department, NHIDCL and its Contractor, and PWD (Roads) shall ensure strict enforcement of this order. Any violation shall attract actions under relevant provisions of the law.

This order is issued in the interest of public safety and shall remain in force until further order.


