**PUBLIC NOTICE**

In partial modification to the previous **Public Notice** dated 19<sup>th</sup> August, 2025 wherein the arrangement for traffic regulation will be ended on the 31<sup>st</sup> of August, 2025 for the stretch from **Laitlyngkot to Lyngkyrdem (Chainage Kms 24+00 – 37+00)**, the general public and commuters are hereby informed that the closure shall remain in force with a slight modification in the timings which shall be as follows :-

**During Daytime : 11:30 AM – 04:00 PM**

**&**

**During Night-time : 09:00 PM – 04:00 AM.**

The above closure arrangement will be temporary and on a daily basis for a period effective from Monday, the **01<sup>st</sup> of September, 2025** until the **15<sup>th</sup> of September, 2025**. A subsequent notice shall be issued with restrictive timings that will be changed keeping in view the requirements, thereafter.

All traffic will be permitted to cross from both ends (i.e. Lyngkyrdem & Laitlyngkot) latest by **11:30 AM** after which from **12:00 Noon** onwards, construction works will be started by the concerned company along the said stretch.

All commuters and members of the public are further **strongly advised to exercise extreme caution** while commuting through this stretch and to kindly **avoid taking non – essential travel** during or immediately after **heavy rainfall** and also during **night-time hours**.

Emergency health services will be facilitated during the closure periods and they may contact the Pynursla Police Station's Phone Number. : **690 921 7154** for any co-ordination requirement with the construction company.
