PUBLIC NOTICE

In partial modification of the previous Public Notice dated 26th September, 2025 regarding restriction on traffic movement along the stretch from Laitkyngkot to Lyngkyrdem (Chainage Kms 24+00 – 37+00) of the Shillong – Dawki road, it is hereby informed to the general public that *relaxation* from the usual traffic restriction will be in place for **two full consecutive days**, i.e., for tomorrow, the **01st of October, 2025 & 02nd of October, 2025**.

Subsequently, the daily traffic restriction will be re-imposed as earlier with effect from the **03rd of October 2025** until further notice as per the usual timings mentioned below:

During Daytime: 11:30 AM – 04:00 PM

During Night-time : 09:00 PM – 04:00 AM.

All commuters are advised to exercise due caution and drive safely while travelling along the said stretch of the Shillong – Dawki road. Night travel and travel during heavy rainfall are further discouraged as the area may remain sensitive despite no construction works / activities.

Emergency health services will be facilitated during the closure periods and they may contact the Pynursla Police Station's Phone No. 690 921 7154 for any co-ordination requirement with the construction company.
