**NOTIFICATION**

**Dated Shillong, the 23<sup>rd</sup> June, 2021**

**No.PER.10/92/85** – In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Meghalaya is pleased to make the following Rules to further amend the Meghalaya Civil Service Rules, 1975 namely :-

1. **Short title and commencement-**(1) These Rules may be called the Meghalaya Civil Service (Amendment) Rules, 2021.

(2) They shall come into force from the date of this Notification.

2. **Amendment of Rule 6** - In Rule 6 of the Meghalaya Civil Service Rules, 1975, (hereinafter referred to as the principal Rules), after the existing sub-rule (5), a new sub-rule (6) shall be added as follows:-

“(6) The marks obtained by the Meghalaya Civil Service officer in the Induction Training at Meghalaya Administrative Training Institute shall be added to the marks obtained by the officers in the Competitive Examination conducted by the Meghalaya Public Service Commission. The total marks thus obtained will determine the final ranking and seniority of the officers”.

3. **Amendment of Rule 10** - In Rule 10 of the principal Rules, after the existing sub-rule (3), new sub-rules (4) and (5) shall be added as follows, namely:-

“(4) No person shall be appointed who, after such medical examination as the Governor may determine is not found to be in sound mental or bodily health or free from any physical defect or infirmity which may render him unfit in the discharge of his duties”.

“(5) No person shall be appointed to the service who has been convicted for any offence involving moral turpitude”.
